Sub: Proposal for Energy Conservation and Emission Reduction

More than three quarters (77%) of EU citizens think climate change is a very serious problem at this moment. A majority of Europeans think that the EU (56%), national governments (56%), business and industry (53%) are responsible for tackling climate change. 35% hold themselves personally responsible. More than eight in ten respondents think that it is important that their national government (86%) and the European Union (85%) take action to improve energy efficiency by 2030 (e.g. by encouraging people to insulate their home, install solar panels or buy electric cars). 58% of EU citizens think the use of renewable energy sources should be accelerated, energy efficiency increased, and the transition to a green economy sped up, Considering energy price spikes and restrictions on gas supply due to the actions of Russia.

More than three quarters (77%) of all respondents think climate change is a very serious problem at this moment – ranking the seriousness of climate change between 7 and 10 on a scale to 10. Climate change is considered the most serious problem facing the world by respondents in seven countries: Belgium, Denmark, Germany, Ireland, Malta, the Netherlands, Austria, Finland, and Sweden. It ranks among the top three in 16 of the 27 Member States.

Three quarters of respondents (75%) agree that taking action on climate change will lead to innovation that will make EU companies more competitive (29% totally agree, 46% tend to agree). Almost as many (73%) agree that the cost of the damage caused by climate change is much higher than the cost of investing in a green transition (33% totally agree, 40% tend to agree). Seven in ten respondents (70%) agree that reducing fossil fuel imports from outside the EU can increase energy security and benefit the EU economically (27% totally agree, 43% tend to agree). Almost eight in ten (78%) agree that more public financial support should be allocated to the transit.

Please start from now on, starting from saving every ounce of electricity, every drop of water, every piece of paper, every grain of food, and becoming a model of actively practicing energy conservation and emission reduction on for clean energies, even if it means subsidies to fossil fuels should be reduced (36% totally agree, 42% tend to agree).

CPE Italia is working in this direction with a series of actions, described below, also by raising awareness among its staff.

1. Turn off the lights, air conditioning, computer, projector, and other electrical equipment when leaving the office, meeting room, and guest room. Equipment and lighting that are not used on the production line should be promptly turned off during employee rest periods.
2. Water is the source of life, saving water, drinking water without surplus, turning off the faucet in a timely manner after washing hands and dishes, to ensure that people are disconnected from water and avoid wasting water resources.
3. Cultivate the habit of double-sided printing and promote paper reuse. Recycle cardboard boxes as packaging fillers, using cardboard processing machines, consequently, reduce the use of disposable plastic packaging and use more reusable packaging.
4. In summer, the temperature of the air conditioner should not be lower than 26 ° C. When the room temperature is lower than 30 ° C, the air conditioner should not be turned on.
5. Increase in the fleet of hybrid fuel company cars to reduce emissions.
6. Continue installing a photovoltaic system covering all CPE European production sites, to increase the % of renewable energy used for the production of CPE plants in Europe.

CPE is promoting and implementing actions to increase energy savings and reduce the use of plastic products; all this in an attempt to oppose pollution and degradation of our planet.
